INSTRUCTIONS FOR COMPLETING THE APPLICATION PACKET

To meet the eligibility requirements for a Fuller Scholarship you must be:

1. Able to demonstrate financial need (determined by filing the FAFSA)
2. Currently in your senior year at a high school located within Hartford County
3. Maintaining a grade point average of 70 or better (or its equivalent)
4. Member of the UCC/Congregational Church and "professed to be of the Congregational faith"
5. Planning to attend a fully accredited four-year college as a full-time candidate for a baccalaureate degree

Document /Deadline Requirements:

Mail your FAFSA (Free Application for Federal Student Aid) to federal processor by **March 1**.

You may obtain a FAFSA application from your high school guidance counselor or at www.fafsa.ed.gov

To meet the deadline for the application process, you must submit the following documents by **May 15**:

- Application for a Frank Roswell Fuller Scholarship
- Copy of your high school transcripts
- Church Recommendation form to the appropriate person, requesting that it be completed and submitted by due date
- Copy of your SAR - **Student Aid Report** (you will receive your SAR directly from the federal processor); please submit all pages of your SAR
- Copy of your college's Financial Aid Award Notice

The Fuller Scholarship Committee meets in June to select recipients, and notifies all applicants in July. If you are awarded a Frank Roswell Fuller Scholarship, you must accept the award in writing and have a final transcript of your high school grades sent to the scholarship fund.
